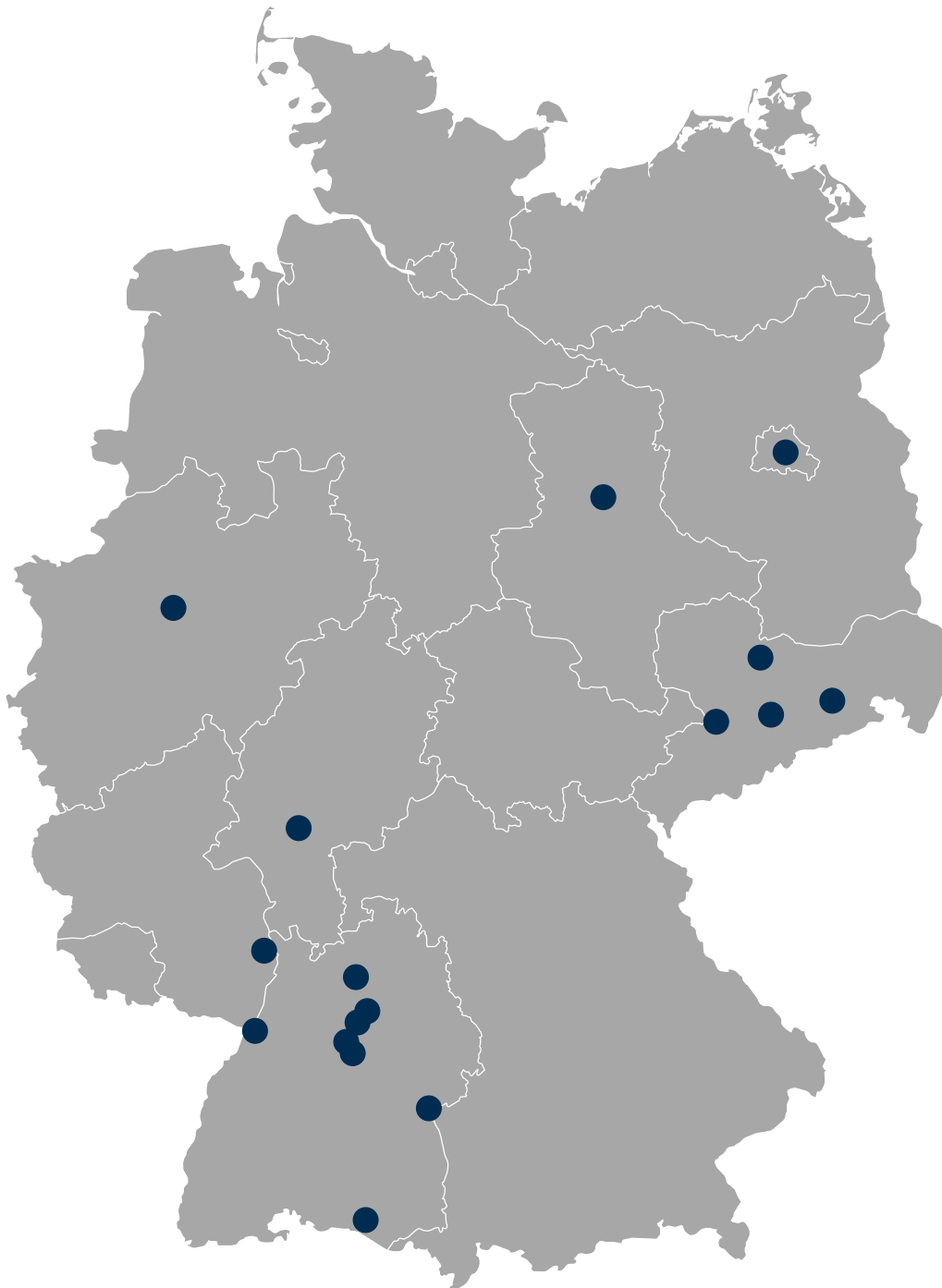

- [ October 2007 ] Expansion of Stuttgart office, cooperation with Dr. Hohberg Rechtsanwälte
- [ January 2008 ] Merger with MFP Morlock Faigle & Partner in Heilbronn
- [ January 2009 ] Dr. Ott Audit Tax GmbH expands in Magdeburg and Frankfurt am Main
- [ May 2011 ] Establishment of the Berlin branch
- [ July 2014 ] Establishment of the Dortmund location
- [ January 2017 ] Merger with the law firm hegmann metter in Stuttgart
